A Prescrição das Pretensões Coletivas Lorena de Mello Rezende Colnago, 2022-08-22 Lorena Colnago apresenta uma pesquisa extensa, tráfegando por águas agitadas com destemor. A pesquisa parte de uma constatada “lacuna normativa”. A prescrição é matéria mal resolvida, a meio caminho entre o direito material e o direito processual. Portanto, qual a sua natureza jurídica? Por óbvio, essa é uma questão teórica e a decisão não depende da natureza, mas da justificação racional do instituto e de seus efeitos sociais. Caso seja norma processual, as regras aplicáveis são tempus regit actum, valendo apenas para os fatos processuais não ocorridos e consumados; caso seja de direito material, em casos como o direito sancionador (especialmente o penal), poderá a prescrição retroagir? Muda de “natureza” se estivermos falando do instituto da prescrição intercorrente? Enfim, além da questão do regime do direito intertemporal, a contagem do prazo (o impedimento, como fala a tese), a suspensão e a interrupção do prazo são elementos que interferem no reconhecimento ou não da prescrição. Por isso, por ter tido a coragem de enfrentar o instituto, no direito brasileiro e comparado, a tese já

merece reconhecimento. Fico aqui ombreado com uma afirmação da tese que encontro madura: um instituto como a prescrição precisa ter tratamento harmônico em todos seus aspectos, jurídico, simbólico, político e sociológico. Este trabalho agora publicado está comprometido com esse fim. A matéria prescricional admite, nesse caso, cognoscibilidade “ex officio” (CPC, art. 487, II, 1ª parte)? Como o impulso oficial, ínsito à execução trabalhista (CLT, art. 878, in fine) – mesmo com as atenuações introduzidas pela Lei 13.467/2017 –, interfere com o

fenômeno prescricional? Essas e outras intrigantes perguntas são respondidas nesta obra, com audácia e percuciência, pela Prof.^a Lorena M. R. Colnago, juíza substituta do Tribunal Regional do Trabalho da 2ª Região, mestre pela Universidade Federal do Espírito Santo e doutora pela Universidade de São Paulo, que mais uma vez abre inusitados caminhos nos espaços ainda virgens desta selva gentil que é o Direito Processual do Trabalho.
