Reusing OCL in the Definition of Imperative Languages Fabian Büttner, 2011 The Object Constraint Language (OCL) has proven to be a valuable ingredient for the specification of UML models. It allows to formulate logical propositions for models that typically cannot be expressed in the visual modeling paradigms of UML. We describe applications of our approach in two fields: first, the extension of the UML-based Specification Environment (USE) by an imperative language and, second, the development of the model transformation tool XGenerator2 that has been successfully applied in several eGovernment projects. Our work makes three major contributions. First, we provide a critical review of the embedding of OCL into existing programming languages. Second, we provide a simple but already useful OCL-based imperative language with a sound and formal semantics that can be implemented out of the box using existing OCL engines. Third, our work contributes a general guideline for a safe embedding of OCL into other languages.
